In Minnesota alone, there was over 1 death per day due to an overdose involving opioids. As anesthesiologists, we handle and prescribe opioids to the vast majority of patients under our care. With the current opioid crisis boiling, we need to examine our role in the problem and determine how we can continue to provide the safest care possible for our patients. At the Minnesota Society of Anesthesiologists (MSA) Spring Conference on April 28th, we have a morning program of speakers discussing various perspectives of the opioid crisis and how it will impact us and our patients.

She received her Bachelor of Arts degree from the University of Iowa and later went on to complete her Doctor of Pharmacy degree at Creighton University. She is Board certified in psychiatric practice. Her current position is the Director of Clinical Practice for the department of pharmacy Rochester hospital campus. Her clinical practice for the past 15 years is in the outpatient chronic pain rehabilitation program. Dr. Cunningham was appointed as a non-physician provider member of the Minnesota Department of Human Service's Opioid Prescribing Work Group.



Sergeant Tim Parkin Olmstead County Sheriff's Office Rochester, Minnesota Sergeant Parkin started in Law Enforcement in 2004 in Las Vegas, NV. In 2007, he transferred to Olmsted County Sheriff's Office in Rochester, MN. In 2010, he became a Narcotics Investigator with the Southeast Minnesota Narcotics and Gang Task Force. Over the last 14 years, his responsibilities have included narcotics investigations, including purchasing narcotics, identifying narcotics and staying informed of current narcotic trends. He is a Clandestine Lab Technician, responsible for dismantling methamphetamine labs and providing expert testimony in court. He currently supervises patrol officers as Sergeant of a patrol division.



Charles Reznikoff, M.D. Assistant Professor of Medicine University of Minnesota HCMC and Northfield Hospital

Dr. Reznikoff is an addiction medicine and internal medicine doctor who works at HCMC and Northfield Hospital. He is part time hospitalist, part time addiction medicine outpatient doctor, focusing on opioid addiction, and part time consultant to a pain clinic evaluating high risk patients. He participates in the DHS opioid work group and the ICSI pain guidelines.



Senator Julie Rosen District 23 Minnesota State Senator Minneapolis, Minnesota Senator Rosen is serving her fifth term as a Minnesota State Senator representing District 23, which includes all or portions of Blue Earth, Faribault, Jackson, Le Sueur, Martin, Waseca and Watonwan counties. Senator Rosen chairs the Senate Finance committee. Her other committee assignments include the Energy and Utilities Finance and Policy, the Health and Human Services Finance and Policy, and the Human Services Reform Finance and Policy committees. In addition, Senator Rosen chairs the Legislative Commission on Pension and Retirement and the Legislative Commission on Minnesota Sports Facilities.

As a freshman senator, Rosen earned the distinction of being a leading authority on methamphetamine and other drug-related issues. She organized the Minnesota Meth Task Force and, under her direction and leadership, developed and passed the groundbreaking Minnesota Meth bill in 2005. This law is the most aggressive and comprehensive meth legislation in the nation. Her service earned her the "Freshman Legislator of the Year" award.

She continues to work passionately towards fighting drug use among children and adults. In 2017, Senator Rosen authored or co-authored each of the five Opioid Reform Act bills. "We are seeing this problem in every corner of the state, and it's escalating," said Rosen. "We need to be proactive in eliminating opioid abuse and educating the public about this growing crisis. We are taking strong, appropriate steps at the state level to address this issue head on."



Nafisseh Warner, M.D.

Assistant Professor of Anesthesiology Mayo Clinic Rochester, Minnesota Dr. Warner is a pain physician and clinical researcher in the Division of Pain Medicine of the Department of Anesthesiology and Perioperative Medicine at the Mayo Clinic in Rochester, Minnesota. She splits her time evenly between providing clinical care for patients with acute and chronic pain states and performing patient-centered research. Her research interests involve assessment of patterns of opioid use following surgical procedures, identification of factors impacting the transition from episodic to long-term opioid use and development of educational tools to modify opioid prescribing behaviors.
